# Background

The Buffalo City TVET College hereby invites Built Environment Contractors with a CIDB Grading of 1 GB or Higher in the following Class of works (GB,) for inclusion into a panel of three contractors to provide maintenance and repairs for minor plumbing works on a rotation basis. Appointed contractor will be invited as and when required by Buffalo City TVET College. They are expected to have their resources and planning processes ready to urgently respond (24 hours) to whichever need arises within Buffalo City TVET College.

#### **Problem statement**

The various College campuses, buildings are mostly affected by ageing plumbing network infrastructure that leak and burst during operations. These issues result into escalating direct costs to the physical structure.
